## MINUTES OF THE CRANE COUNTY APPRAISAL DISTRICT BOARD OF DIRECTORS

- 1. Byron Bitner called the meeting to order at 1:43 p.m.
- 2. Julie Flores administered the Oath of Office to new Board Member Barbara Abbott.
- 3. Emily Barton made the motion to approve the minutes from the August 16, 2023 meeting. Second by Judy Crumrine. Motion carried unanimously.
- 4. Emily Barton then presented the Treasurer's Report with a checking account balance of \$188,357.56. Emily Barton made the motion to approve the Treasurer's Report as presented. Second by Judy Crumrine. Motion carried unanimously.
- 5. The Board of Directors then reviewed all bill payments since the August 16, 2023 meeting. Emily Barton made the motion to approve all bill payments as presented. Second by Judy Crumrine. Motion carried unanimously.
- 6. Byron Bitner then discussed with the Board the changes that needed to be made to the 2023 budget. (See the attached list of Line-Item Shifts) After some discussion, Judy Crumrine made the motion to approve the line item shifts as presented and to pay for any shortfall from the undesignated fund balance if necessary. Emily Barton made the motion to approve the switching of health insurance for Kelly Lee and Julie Flores to the Crane County health insurance group. Second by Judy Crumrine. Motion carried unanimously.
